Dear Alderney Wildlife Trust Member,

I am delighted to enclose the latest copy of the Alderney Wildlife Trust's magazine, full of incredible content demonstrating what a beautiful and precious place Alderney is. I also have the pleasure of enclosing a copy of the 2025 Members' Meeting notice. We are hugely grateful for the support of all our members; you are the powerhouse that enables all our work.

This year's Members' Meeting will be important for the following reasons:

The future of our wild island 5.30pm – before the start of the formal Members' Meeting we will be having a presentation on the future of Alderney's wildlife and our plans for the coming 5 years. A series of short talks on a number of topics, with the chance for members to ask questions and provide input and feedback, accompanied by refreshments.

Membership Update - for the first time in its 23-year history the AWT will be increasing its membership rates. In reviewing our membership it is clear AWT members receive more membership benefits than nearly any other of the 46 wildlife trusts (www.alderneywildlife.org/become-a-member), at far the lowest rates. At the Members' Meeting there will be a presentation on what is being proposed, but the new rates will come into force on 1st July 2025, all new members having to pay the increased rates from then.

To help our existing members who are due to renew before the 31st December 2025, the AWT will be offering an opportunity to do this at the current rate before the 1st of July. *For example - someone whose single adult membership lapses on the 19th November 2025 will be able to renew their membership at the existing £20 before 1st July, and their next renewal will not be due until the 19th November 2026, though this will be at the new rate.*
